FACILITY USAGE GUIDELINES FOR ALL EVENTS AND MATCHES THROUGH CATA

- The use of University facilities is a privilege, and CATA participants are expected to be good citizens and respect the rights of others. Responsible conduct is expected and required. Individuals who engage in unacceptable or unsafe behavior may have their access to facilities revoked.
- 2. Reservations for UT courts are to be made through the Capital Area Tennis Association (CATA) at least 48 hours prior to use.
- 3. CATA players will register at the UT-Whitaker Front Desk and be directed to reserved courts. DO NOT ASK FOR COURT RESERVATIONS AT THE UT-W DESK! The desk staff do not make any reservations and CATA could lose its privilege to use the courts if we are seen to be skirting the RecSports protocols.
- 4. Additional courts, even if available, are not to be used unless CATA has reserved the courts.
- 5. Payment for tennis courts will be initiated by CATA, via invoice. Preferred method of payment is through Paypal. Please contact the director of leagues at leagues@austintennis.org if an alternate payment method is needed.
- 6. Supervision of the facilities and events is the responsibility of UT-W departmental staff. Any necessary on-site decisions regarding activities or problems related to CATA reservations will be made by these individuals, who have the final authority on-site.
- 7. CATA will be charged for damage beyond ordinary wear and tear to facilities, fixtures and equipment. Any additional, unanticipated expense (i.e., damage, an event running over allocated time, excessive cleanup required, etc.) will be billed to the reservation holder. Payment for these overages must be submitted to CATA upon receipt.
- 8. Willful destruction or abuse of University property will result in forfeiture of facility use privileges.

- 9. Proper athletic attire must be worn. Non-marking athletic shoes must be worn on the tennis courts. Shirts and shoes are required.
- 10. Food or drink may not be consumed on the tennis courts, other than water or sports drinks. Glass containers are strictly prohibited.
- 11. Concessions may not be sold within the facilities or prior to entering the facilities.
- 12. No alcoholic beverages are to be brought into or consumed on the premises.
- 13. Only guide animals are permitted at the facilities.
- 14. Smoking is not permitted on any University property.
- 15. The use of bicycles, roller skates, rollerblades and skateboards are prohibited at all facilities.
- 16. Recreational Sports must review all advertisements prior to posting.

Failure to observe these guidelines will result in forfeiture of the right to make reservations. CATA assumes the responsibility for enforcing the above referenced rules and regulations.

Participation is on a voluntary basis and at the individual's own risk. The University of Texas at Austin and Recreational Sports cannot assume responsibility for lost or stolen property or injuries sustained while participating.
